97/20. Minutes of the Parish Council meeting held on the 2nd November 2020 Council resolved to approve the minutes.

98/20. Matters Arising - Actions

Ref: 87/20 – The PC Facebook page had been set up by Cllr Jarvis and was now active. Council resolved for the page to provide information only with all resulting comments from the community to be addressed to the Clerk.

100/20. District/ County Councillor Report.

Cllr Staveley highlighted a working group report by CDC that praised the effectiveness of service during the Covid 19 pandemic. In particular the report thanked staff for their dedication to a high service provision whilst sometimes working away from their normal working environment. Leisure staff had been utilised in other departments and some had been working from home. 2000 businesses had received grant funding.

101/20. Car Park - Tree removal & replacement.

The Clerk had applied to YDNP for the removal of a diseased tree within the car park area, this following a request by a resident due to the tree suffering from Ash dieback. YDNP would give permission if it was possible to replace the existing tree with two saplings. Council resolved to agree to the proposal and would inform YDNP of the required location for the new trees. **Action** – Clerk to liaise with YDNP & contractor.

102/20. Flooding – Letter from resident.

The Clerk had received communication from a resident in the form of letters regarding the recent flooding that occurred in Langcliffe, and efforts to try and prevent a reoccurrence. Council discussed flooding problems relative to the village including gullies & drains.
