# 113/20. Minutes of the Parish Council meeting held on the 7<sup>th</sup> & 15<sup>th</sup> December 2020 Council resolved to approve both minutes.

## 114/20. Matters Arising - Actions

## Minutes 7<sup>th</sup> December

Ref: 109/20 – The Clerk informed Council that after consulting NYCC footpath database it was discovered that Howsons Lane was not registered as a public footpath and would not qualify for maintenance purposes by NYCC.

Buxton Park access is registered as a designated footpath. Council discussed the surface of the footpath and noted that the width of the path allowed pedestrians to negotiate access safely, it was noted that vehicle access to the footpath had contributed to an uneven surface in places.

All defective lighting reported previously had received repair.

Minutes 15th December Council discussed comments received by the planning applicant.

#### 115/20. Public Participation.

Residents had reported to Council that sheep had crossed the broken cattle grid and were once again in the village causing a nuisance and contributing towards traffic safety issues. The Clerk had sent an email to NYCC Chief Executive reminding him of the promise made by him to J. Smith MP that the cattle grid would be repaired. A date had been requested by the Clerk for a repair to the grid.

# 116/20. District/ County Councillor Report.

Cllr Staveley informed Council that the Crime & Disorder Committee had met before Christmas but as yet no yearly crime figures were available. The Police had reported that currently there was not a policy to turn people away from visiting the area as yet, as all directives were advisory only.

The Police strongly discourage rural vigilante actions against visitors to the area, with current advice to report any issues directly to the Police.

Cllr Jarvis informed Council of the current situation regarding play equipment, Council discussed with Cllr Staveley the provision of wood based equipment. Agenda item for future meetings.

#### **117/20.** Car Park – Tree removal & replacement.

The Clerk informed Council that the Tree Surgeon would remove the diseased Ash tree from the car park on the 7<sup>th</sup> January if vehicles could be relocated prior to the works.

Cllr Bagnall volunteered to arrange for vehicle relocation.

**Action** – Clerk to liaise with contractor.

## **118/20. Flooding** – Follow up.

The Clerk had inspected the works undertaken by NYCC Highways following the flooding in November. The culvert from the village to the cattle grid had been excavated and water was running through effectively, the cattle grid was full of water and had frozen solid allowing sheep to pass the grid (see item 115/20). Council discussed measures relative to flood prevention with prompt reporting of blocked drains to NYCC to be observed.
